Your copyright

You retain copyright in your photograph. By entering the Connected Libraries 'Picture Casey' Photographic Competition, you confirm that you are the copyright owner of the photograph and that you have the right to grant the permissions described below.

Connected Libraries does not acquire ownership of copyright in your photograph.

Making your photograph part of the Local History Collection

Photographs selected for inclusion in the Connected Libraries Local History Collection may be:

- preserved as part of the permanent collection;
- catalogued and described in Connected Libraries' collection management systems;
- digitised and made available online;
- displayed in Connected Libraries libraries, exhibitions and displays;
- reproduced in Connected Libraries publications, websites, social media and promotional and educational materials; and
- made available through appropriate library, archive and cultural heritage discovery services.

Creative Commons licence

By submitting your photograph, you grant Connected Libraries a **Creative Commons Attribution 4.0 International (CC BY 4.0) licence** to make the photograph available to the public.

This means that you retain copyright in your photograph, while allowing other people and organisations to copy, share, publish and adapt the photograph, including for commercial purposes, provided that they:

- acknowledge you as the photographer;
- provide a link to the applicable Creative Commons licence where reasonably possible; and
- indicate if changes have been made to the photograph.

The CC BY 4.0 licence does not transfer copyright ownership from you to Connected Libraries.

Your moral rights

Your moral rights as the creator of the photograph are separate from copyright ownership and are not transferred to Connected Libraries.

Connected Libraries will identify you as the photographer when displaying or reproducing your photograph.

Your responsibilities

By submitting a photograph, you confirm that:

- you took the photograph;
- you have the right to grant the CC BY 4.0 licence described above;
- the photograph does not knowingly infringe another person's copyright, trade mark or other intellectual property rights;
- you have obtained any permissions that may be required in relation to identifiable people appearing in the photograph;
- you have obtained any permissions necessary for any third-party material incorporated into the photograph; and

- you have the right to submit the photograph to the competition and to permit Connected Libraries to include it in its permanent Local History Collection.

Cultural, personal or access restrictions

Connected Libraries recognises that some photographs may contain or relate to **Aboriginal and Torres Strait Islander people, communities, cultural practices, places, knowledge, stories, objects or other cultural material**.

Copyright ownership does not necessarily provide the photographer with authority to make all such material freely available. Aboriginal and Torres Strait Islander peoples may have **Indigenous Cultural and Intellectual Property (ICIP)** interests that are separate from copyright.

If your photograph contains Aboriginal or Torres Strait Islander cultural material, or any other material that you believe may require restricted access or consultation, please tell us below.

This may include photographs involving:

- Aboriginal or Torres Strait Islander people, communities or cultural practices;
- culturally sensitive places, objects, knowledge or stories;
- identifiable individuals where there may be privacy or other concerns; or
- any other material that you believe should not be freely available online.

A photograph may be accepted into the permanent Local History Collection but have **restricted access or additional cultural protocols** rather than being immediately made available under a Creative Commons licence.
